## **RULES AND REGULATIONS GOVERNING EXHIBITS**

SETTING UP	Booths may be set up on Wednesday, June 24, 2009, between 3 pm and 5 pm, and removed after 9:15 p.m., Wednesday, June 24, 2009.
HOURS	Exhibit hours will be 6:30 pm to 9 pm, Wednesday, June 24, 2009.
CONTRACT	The space contracted is to be used solely by the company or individual whose name appears on the contract. However, all merchandise sold by the booth holder may be displayed within his booth.
BOOTH	Each booth will be approximately 8' x 6' and equipped with curtain dividers (no backdrops), chairs, one table with cover, and electrical power. MTADA will also provide "set-up and tear down" help through the Holiday Inn Downtown and K&J Convention Services. It is permissible to display merchandise that will fit comfortably within your booth's area. All electrical extension cords will be supplied by the exhibitor - not the hotel.
SIGNS	Booth holders may post signs advertising the products within the booth. No signs or other articles may be posted, nailed, or otherwise attached to any of the pillars, walls, doors, or other parts of the building.
INTOXICANTS	This agreement does not authorize the booth operator to serve, sell, or give away any wine, beer, ale, liquor, or other intoxicants on the leased premises.
LIABILITY	Each booth operator is entirely responsible for the space leased by him/her and has sole responsibility for the repair and maintenance of the space leased by him/her, including the sole responsibility of keeping said space free from any condition which might be dangerous to persons coming upon the premises.

INSTRUCTIONS	Neither the Montana Automobile Dealers Association, Idaho Automobile Dealers Association, or Wyoming Automobile Dealers Association as associations and corporations, the employees or members thereof, nor the Big Sky Resort, owners, managers, or employees thereof, will be responsible for any injury, loss, theft, damage by fire, or injury of any kind to any person or article. Exhibitors desiring insurance must procure it at their expense. Each exhibitor will be liable for damage, if any, caused by his/her exhibit and also agrees to indemnify MTADA & IADA and the Holiday Inn Downtown for any loss sustained by reason of any occurrence upon leased premises during the term of lease.
